



# CORONAVIRUS/COVID-19 RENTAL WAIVER OF LIABILITY

The novel coronavirus (“COVID-19”), has been declared a worldwide pandemic by the World Health Organization, and is reported to be extremely contagious. The state of medical knowledge is evolving, but the virus is believed to spread from person-to-person contact and/or by contact with contaminated surfaces and objects, and even possibly in the air. People reportedly can be infected and show no symptoms and therefore spread the disease. The exact methods of spread and contraction are unknown, and there is currently no known treatment, cure, or vaccine for COVID-19. Evidence has shown that COVID-19 can cause serious and potentially life threatening illness and even death.

As a condition of being allowed to rent or reserve the park, facility or field within the City of Roanoke, the person and/or entity must follow all applicable Executive Orders currently in place to protect citizens from COVID-19 and to require all of their participants to comply with all such Executive Orders. **Despite following all of the Executive Orders, the City of Roanoke cannot completely guarantee that people participating in events in parks or facilities within the City of Roanoke will not becoming exposed to, contract, or spread COVID-19.** Therefore, if you choose to rent or reserve a park, facility, or field within the City of Roanoke you may be exposing yourself and/or your participants to COVID-19 and/or increasing the risk of contracting or spreading COVID-19.

**ASSUMPTION OF RISK: I have read and understood the above warning concerning COVID-19. I hereby choose to accept the risk of contracting COVID-19, for myself and/or for my participants.**

**WAIVER OF LAWSUIT/LIABILITY:** I hereby forever release and waive my right to bring suit against the City of Roanoke and its officers, managers, officials, agents, employees, volunteers or other representatives in connection with exposure, infection, and/or spread of COVID-19 related to my rental or reservation of a park, facility, or field within the City of Roanoke. I understand that this waiver means I give up my right to bring any claim against the City of Roanoke for personal injuries, death, disease or property losses, or any other loss, including but not limited to claims of negligence and I give up any claim I may have to seek damages, whether known or unknown, foreseen or unforeseen.
